Withdrawal Policy (for Digital Services)



Applies to **consumers** (§ 13 BGB). Entrepreneurs (§ 14 BGB) generally have no statutory right of withdrawal.

Right of Withdrawal

You have the right to withdraw from this contract within **14 (fourteen) days** without giving any reason. The withdrawal period is fourteen days from the day the **contract is concluded**.

To exercise your right of withdrawal, you must inform us

by means of a clear statement (e.g., by email or letter) of your decision to withdraw from this contract. You may use the model withdrawal form linked below, which is not mandatory. To meet the withdrawal deadline, it is sufficient for you to send your communication before the withdrawal period has expired.

Effects of Withdrawal

If you withdraw from this contract, we will reimburse you all payments that we have received from you without undue delay and at the latest within **14 (fourteen) days** from the day on which we received notice of your withdrawal.

We will use the same means of payment that you used for the original transaction: refund in **SOL** to the wallet originally used. The **EUR amount** will be converted into **SOL** at the exchange rate applicable at the time the original payment was received. You will not incur any fees for such reimbursement.

Commencement During the Withdrawal Period & Compensation for Value (Services)

If you requested that we begin providing the service **before the withdrawal period** has expired, your right of withdrawal remains in effect until the contract has been fully performed.

If you withdraw **before** we have fully performed the service, you must pay compensation for the value of the partial service already provided up to the time of your withdrawal. The amount is calculated proportionally based on the contractually agreed total price for the service period.

Your right of withdrawal **lapses** only if we fully perform the service within the withdrawal period and you had previously expressly consented to performance commencing during the withdrawal period and acknowledged that you are aware that you may lose your right of withdrawal upon full performance. *Legal basis:* § 356 (4), § 357 (8) BGB.

Digital Content (only if additionally provided)

If, by way of exception, we provide **digital content** (not supplied on a tangible medium) separately (e.g., downloads), the right of withdrawal expires when execution begins, after you have expressly consented to the commencement of execution and confirmed your knowledge that this causes the loss of your right of withdrawal.

Legal basis: § 356 (5) BGB.

Statutory Warranty Rights Unaffected

Irrespective of your right of withdrawal, your **statutory rights for digital products/services** under §§ 327 et seq. BGB remain **unaffected**.

Pseudonymous Allocation & Refund (Telegram ID / Tx Hash / Wallet)

We process contracts and refunds pseudonymously using technical identifiers. To uniquely attribute your declaration and payments, we require the following information (instead of name / address):

Exclusion or Early Expiry of the Right of Withdrawal

The right of withdrawal does not apply to contracts for the supply of digital content which is not supplied on a tangible medium **where** we have begun execution after you have

- expressly consented to us commencing execution before the withdrawal period has expired; and
- acknowledged that you lose your right of withdrawal once execution has begun.

For **services**, the right of withdrawal expires early if the service has been fully performed and you had previously expressly consented to execution during the withdrawal period and acknowledged your awareness of the possible loss of the right of withdrawal.
